# BONVILLE GOLF RESORT

## WAIVER OF LIABILITY AND INDEMNITY FORM

### USE OF GOLF COURSE, GOLF CARTS, ACCOMMODATION, CLUBHOUSE AND RESTAURANT

---

This agreement waives the liability of Ironhill Management Pty Limited ABN 64 085 909 922 trading as Bonville International Golf Resort along with all of their management, staff, directors and shareholders hereinafter referred to as "The Resort". In consideration of and as a condition of The Resort permitting the use of The Resort's services, facilities and the equipment, I hereby acknowledge and agree that:

- As a condition of entry to The Resort use of The Resort's facilities I agree to release and indemnify The Resort, on behalf of myself, my heirs, my executors and the parties accompanying me as set out below, their management, staff, directors and shareholders in respect of any injury, illness, changes in my medical condition or state of health (whether permanent or temporary), loss or damage (including property) arising directly or indirectly from my presence on the property and for the use of the facilities whether it is caused by my negligence, or any other parties actions whether voluntary or otherwise (including that of The Resort's employees, agents, directors or contractors), Act of God or force majeure. I hereby assume full liability for any detriment to me as a result of such injury, illness, loss or damage. I hereby indemnify all parties referred to above against any successful claims made against them which arise as a result of my own actions on the premises hereinbefore referred to.
- I will comply with all rules imposed by Ironhill Management Pty Limited ABN 64 085 909 922 trading as Bonville International Golf Resort regarding the use of the facilities and equipment. I agree to conduct myself in a controlled and reasonable manner at all times, and to refrain from using any equipment in a manner inconsistent with its intended design and purpose.
- I acknowledge that I am aware of the inherent dangers in entering the premises of The Resort due to the very nature of the business. Being on the property, in close proximity to the game of golf can be dangerous and injuries, damage or loss can occur. I acknowledge these risks and utilise The Resort's facilities, services and equipment at my own risk. I acknowledge that The Resort is covered with high trees, heavy bush, dams, bunkers, steep terrain, bridges etc and is populated by many birds, animals and insects (some of which birds, animals and insects may be dangerous).
- I confirm that in respect of any person/s under the age of 18 years, I am acting for them as guardian and I am responsible for their actions and accept full responsibility for those who are passengers in the golf cart who are under the age of 18 years.
- I acknowledge that the use of the services and facilities including the golf course, clubhouse (including showers and spa), swimming pool, restaurant and accommodation at The Resort may involve dangers, inherent or hidden and is voluntary and at my own risk.
- I am solely responsible for the safety and well-being of myself plus the parties accompanying me if any and others. I understand that The Resort may not provide supervision, instruction, or assistance for the use of the facilities and equipment.
- It is my sole responsibility to ensure the safe keeping of my personal property and consider my physical ability, level of fitness and suitability when using The Resort's services and facilities. If I am unsure, I will consult a physician before using these facilities especially if I have not exercised or played sport for a while.
- I confirm that I am not an unaccompanied incapable person and not bound by any court orders regulating my behaviour.
- There are security cameras around the property, and I acknowledge and accept that the Management may rely on and use the footage of those cameras as they deem appropriate. I accept that this usage is not a breach of my privacy.
- I will not invite any other persons (non-guests) to use The Resort's facilities unless I/they have permission from The Resort's Management to enter The Resort.
- I acknowledge that if I choose to store my personal belongings at The Resort either in my room and/or in the safe in my room, the Cart Shed or the Locker Room, that The Resort will take all care but bear no responsibility for any loss or damage to my property whilst it is stored and that I will make no claim on The Resort in respect of such loss or theft.
- I acknowledge that while at The Resort I will comply with all signs and all reasonable directions and request made by The Resort and its staff.
- I agree that any charges arising subsequent to my checkout will be debited to the credit card on file. I am aware that any damages that occur to the rooms, furnishings or fittings, a minimum charge of \$95.00 will apply but may be more depending on damages. I am aware that I will be charged for damages including but not limited to extra cleaning, repairing or replacing damaged or broken items, lost room night revenue if room has to be closed off for any period.
- I understand that I am responsible for dressing in the appropriate attire and shoes to abet weather conditions including but not limited to rain, heat, wind, hail and chill.

## WAIVER OF LIABILITY AND INDEMNITY FORM

### USE OF GOLF COURSE, GOLF CARTS, ACCOMMODATION, CLUBHOUSE AND RESTAURANT

- I agree to return the golf cart to The Resort Cart Shed immediately following the completion of the specified play, in as good and same condition as the undersigned received including the supplied Visage GPS Unit, Club/Ball washer, 2 x towels and 2 x sand dispensers all returned in the condition they were received.
- I acknowledge that the responsibility for the return of the vehicle and its hire will continue until a final inspection by a Resort’s staff member is made. I acknowledge that my responsibility for the cart will be signed off at this time.
- I agree to release and indemnify The Resort for any damages to the cart, personal injury or property damage from or through my use of the golf cart. I agree to pay for all damage or loss to the golf cart and any other hire equipment. The minimum charge for cart damage is \$895.00 rear end and \$495.00 front end.
- I acknowledge that the golf carts cross public roads on numerous occasions throughout the property and I agree to monitor my own alcohol intake to ensure that I am within the legal limit to operate a vehicle.
- I agree that we will carry no more than 2 people in a golf cart at any one time.
- I confirm that the driver of the golf cart at anytime will have a valid and current drivers licence and will provide this to The Resort if requested.
- I acknowledge that in circumstances where The Resort’s course is heavily water logged and this interferes with my general game of golf, then having paid for a round of golf (18 holes), The Resort will offer me the following options; if I have played less than 9 holes, then I can discontinue my round before commencing my second nine holes and then receive a rain-check for either: 9 holes free next time I play, or Half price round (18 holes) next time I play. I will report a rain-check request to The Resort’s Pro Shop immediately after ceasing play.
- I acknowledge that if any of these conditions are legal or unenforceable the offending part is to be disregarded and does not affect the remaining part.

*This remains valid and on foot whilst ever I remain a Member of Bonville Golf Resort and in respect of any claims pending which may arise subsequent to my Membership which may arise in respect of the period during which I was a Member.*

### **Single Membership**

Single Membership is available to members aged 30 years onwards

### **Couple Membership**

Couple Membership is available to married couples or those in a De Facto relationship residing at the same address

### **Intermediate Membership**

Intermediate Membership is available to members aged 25 years up to 30 years of age ie. if aged 30 as at 1<sup>st</sup> April then Single Membership fees would apply

### **Colt Membership**

Colt Membership is available to members aged 20 years up to 25 years of age ie. if aged 25 as at 1<sup>st</sup> April then Intermediate Membership fees would apply

### **Junior Membership**

Junior Membership is available to members aged 15 years up to 20 years of age ie. if aged 20 as at 1<sup>st</sup> April then Colt Membership fees would apply

### **Full Sub-Junior Membership Conditions**

Full Sub-Junior Membership is a membership which is attached to a current member's membership, with the following restrictions:

- It is for the children or grandchildren of members who are under the age of 15 (at the commencement of the membership year) i.e. if aged 14 as at 1<sup>st</sup> April then Sub Junior Membership fees would apply - if aged 15 as at 1<sup>st</sup> April then Junior Membership fees would apply
- The Sub-Junior members are not permitted to operate the golf carts at any time
- The Sub-Junior Members will pay 50% of the cart fees that other Members pay
- The Sub-Junior member is entitled to have a handicap and play in Club Competitions. It is the responsibility of the parent or Grandparent to arrange playing partners or to play with the Sub-Junior themselves as the Sub-Junior will be a passenger in the cart and it is not the responsibility of the Pro Shop to arrange playing partners for Sub-Junior Members.

### **Sub-Junior Membership Conditions**

Supplementary Sub-Junior Membership is a membership which is attached to a current member's membership, with the following restrictions:

- It is for the children or grandchildren of members who are under the age of 15 (at the commencement of the membership year) ie. if aged 14 as at 1<sup>st</sup> April then Sub Junior Membership fees would apply - if aged 15 as at 1<sup>st</sup> April then Junior Membership fees would apply
- The membership allows the child or grandchild to accompany their parent or grandparent (who must be a member) for a game of golf at no additional cost to the supplementary annual membership fee
- The young member must be accompanied by their parent or grandparent
- The member only pays 1 x the single cart fee
- There is a maximum of 2 persons per cart
- The supplementary membership can only be used after 2:00pm subject to available tee times
- The Sub-Junior members are not permitted to operate the golf carts at any time
